DO NOT DISCARD THIS LETTER. As a visitor to the United States, you will need this letter to qualify for a "Form 6" import permit allowing you to bring your firearms into the United States. You will be asked to present an itinerary, and may be asked to show your USPSA or IPSC-affiliate membership card (we suggest you attach copies of both to your Form 6 application). As a competitor, you qualify for the sport shooting exemption that allows a foreign national to possess a firearm while attending shooting events in the United States.

According to the Bureau of Alcohol, Tobacco, and Firearms (BATF) you must submit a copy of this letter, along with your Form 6 application to the BATF Import Branch in Washington, D.C. 90 days prior to your travel dates to ensure the paperwork will be completed on time. A separate Form 6 is needed for each event you attend. Please pay close attention to this requirement while traveling in our country.
